MANNA Worldwide exists to help needy children around the world by addressing the nutritional, educational, and spiritual needs of these children and their families. Meeting these objectives will enable the affected communities to develop toward a more complete way of life.

The primary program service offered by MANNA Worldwide is the operation of nutrition centers and orphanages for indigent children around the world. The number of centers held steady at 129, including 105 overseas outreach centers, 15 orphanages, and 9 U.S. based nutritional outreach initiatives. The feeding programs of MANNA Worldwide are located in approximately 40 different countries and serve over 8,000 children in these locations. The long term goal of these programs is to continue to provide nutritious food, quality education, and to significantly impact the lives of these children in an effort to help break the cycle of poverty and cultivate thriving communities.

4b (Code:) (Expenses \$ 836,203 including grants of \$) (Revenue \$)
MANNA Worldwide provides the opportunity for several hundred people to visit the child development centers and orphanages each year. In 2012, MANNA facilitated over 60 trips to regions around the world where they were able to experience firsthand the impact of MANNA Worldwide programs on the lives of the children and families which are served. Travelers are also able to contribute personally to the long term development efforts of the communities where MANNA projects are actively engaged.

MANNA Worldwide relies on a team of self-funded directors who travel across the country to present mission of the organization. These directors regularly make presentations in churches, civic groups, business luncheons, and conferences to promote MANNA Worldwide and its programs and the benefits of personal and corporate involvement. In addition, the directors are also responsible for the oversight of MANNA projects in their respective regions, accountability for the funds provided for program services, develop new projects, and maintain relationships with existing and potential MANNA Worldwide constituents.
