

Part II. Section 17a In 2012 Alfano, Inc., US secured 23 32% public support (11.47% in 2011); thus meeting the 10% threshold

test to secure its 501(c) 3 public charity status. A shortlist of prospective Directors to add to the Alfano, Inc., US Board was developed.

Cultivation of these prospects began in 2012. Alfano, Inc., US aims to add at least one new Director to its Board in 2013 as a way of

deepening its expertise about the Arab region and widening its basis of public support. Additionally, Alfano, Inc., US identified a US

fundraising consultant - Mr Timothy Runion [NY Charities Bureau ID #32-67-06] who was hired in January 2013 to help Alfano, Inc., US

professionalise and enhance its fundraising outreach efforts in the US in the hope of achieving the 33 1/3 % test in future years. In order to

enable Alfano, Inc., US to solicit charitable donations in New York State, it applied for and secured registration with the New York State

charities bureau on November 19, 2012 [NYS Reg.No.: 43-42-69].

In 2012, Alfano, Inc., US grants enabled Alfano to expand its geographic scope to support innovative community-based organisations

serving disadvantaged communities in Egypt, Lebanon and Libya (previously only Egypt) to implement financially sustainable social

programmes in education and women's empowerment

Alfano, Inc., US' \$190,000 grant helped support development projects with 2 Egyptian organizations: the Bedayaat Foundation and Masr al

Mahrousa Balady Association as well as a development project with Lebanese organization: the "Iqra" Association. Additionally, this grant

helped support three scoping missions to Libya aimed at assessing the country's community-development needs and tailoring a venture

philanthropy strategy to meet them

Egypt: - The Bedayaat Foundation aims to educate and empower 250 street children living in the Badawi shelters slum area of Minya City

through reading and writing classes as well as extracurricular arts programming aimed at building resiliency amongst children at risk. The

Alfano, Inc., US grant helped Bedayaat, a children's centre within the government shelters.

-Masr al Mahrousa Balady Association (MMBA) provides vocational training to 100 boys and girls living in 7 social care centres across Cairo.

By training these children in computer, satellite and mobile repair as well as handicrafts, MMBA is working to ensure that these youth can be

gainfully employed after their release at 18 years old

Lebanon: - Iqra Association. Following a year-long process of scoping, proposal review, due diligence, and project design support, the

Alfano, Inc., US grant was used to support an innovative literacy intervention programme in Lebanon that employs the balanced literacy

approach in public schools across Lebanon to ensure that 560 poor performers remain enrolled in school and unlock the joy of reading.

Libya: - Future Light For Development Organization (FLDO): Three scoping missions to Libya identified high-quality early childhood

education as a major need throughout the country. The Alfano, Inc., US grant was used to design a multi-faceted preschool training

program that leverages the expertise of FLDO to deliver Montessori-style teacher training to 22 preschool teachers with the aim of

improving early childhood education for over 100 children living in Tripoli's poorest neighborhood - Abu Selim
