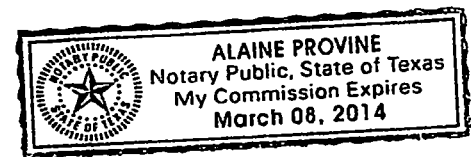

On 05/31/2012 Moon Credit Corp. contributed 30,100 shares of stock in Meador Staffing Services, Inc. to Sure Foundation, Inc. Because Sure Foundation, Inc. is a private non-operating foundation, IRS regulations allow their cost of \$100,000 as a deduction.

Sure Foundation, Inc. issued a contribution receipt in the amount of \$100,000 and recorded it on its books at \$100,000. An independent appraisal firm issued a fair market value opinion at 05/31/2012 of \$668,000 for income tax purposes

On December 28, 2012, Meador Staffing Services, Inc. desired to purchase the shares at \$27.50 per share, and the offer was accepted. Meador Staffing Services, Inc. purchased 12,040 shares for a cash payment of \$331,000, and Sure Foundation, Inc. reported on a cash basis, a capital gain from sale of assets of \$291,100.

The balance of 18,060 shares was financed by accepting a secured note receivable of \$496,650 and deferred the capital gain of \$436,650 until receipt of cash over the next three years plus interest at prime rate.
