All decisions regarding Grants to be extended are then brought to the Board and discussed for approval. The core of the program is discussed to ensure it is in line with our mission and our budget is reviewed to ensure we can support the Grant. If the Grant is approved, the Grant Committee Chair notifies the recipient with a formal letter and a check is distributed. We ask that each program we fund provide updates on their program and how the funds are utilized. Once all RMHC Scholarship winners are notified, each student must submit proof of enrollment to the Treasurer of RMHC of Greater Houston/Galveston. The proof of enrollment must be from the student's university and include their student ID number printed on the document. Once received, the Treasurer sends a request to the Bookkeeper to write a check. The check is written directly to the University and includes the student's student ID number on the check. Once the checks and letters are written, they are sent back to the Treasurer for her signature and then sent via certified mail directly to the student's university.
