

EDUCATION, AWARENESS, ADVOCACY & SUPPORT Hosted 10th annual education and awareness event. New public education materials and videos were produced increasing the visibility of the spectrum of eosinophil associated disease among the public. The eLearning center was enhanced and a new online educational program geared for school aged children was launched, complete with updated educational materials on a variety of eosinophil associated diseases, FAQ's, videos and more. Maintained and expanded online educational content on APFED's website. A two-page summary on the 2011 Updated Consensus recommendations for the diagnosis and management for Eosinophilic Esophagitis was developed and distributed. Developed and produced an educational Webinar Series in different formats in partnership with the University of Michigan. Developed new educational materials in print and video formats for public and patient's education.

RESEARCH APFED distributed several research grants in 2012 totaling over \$ 255,000. Awarded new research initiatives by awarding research grants totaling \$ 400,000 (to be paid over several years) to researchers at noted research hospitals and universities. Presented APFED survey data on patient needs on EoE, EGE and EC at a FDA-sponsored workshop. APFED leadership was an active participant in a National Institute of Health (NIH) working group to address the unmet research needs of rare Eosinophil-Associated diseases. APFED represented the patient's viewpoint and participated in the authorship of the TREAD (Taskforce on the Research needs of Eosinophil-Associated Diseases) document published in 2012.
