During 2012, the San Jose Public Library Foundation either raised or served as the pass-through for over \$700,000 dollars for San Jose Public Library branches and programs. We raise both restricted dollars and unrestricted dollars. The primary focus for the past nine years has been on raising funds for the furnishings, technology and collections for the new bond project libraries as they open. However, as the remaining branches opening dates were on hold until July, 2012, it became impossible to raise funds for those branches in the interim. We held bond project campaigns for the following for the new branches: "Bascom - Received a grant from the Walmart Foundation to sponsoring the Family Learning Center "Seven Trees: Received a grant from the Walmart Foundation sponsoring the Family Learning

The compensation package was developed by reviewing market surveys which provided compensation ranges based on comparable non-profit organizations, location, organization size and the ED's responsibility level. The Board also took into consideration the following: Relationship of the ED compensation to the compensation of other employees, the complexity of the organization and its size, the job duties of the ED, the individual's salary history, and the organization's need for the services of the ED.
