Nature of the Foundation

Unity Productions Foundation (UPF) was incorporated in August, 1999 as an educational organization dedicated to working for peace through the media. UPF produces documentary films for television broadcast, online viewing, and theatrical release, and implements long-term educational campaigns aimed at increasing understanding among people of different faiths and cultures, especially between Muslims and other faiths. We are convinced of the power of media to empower citizens with greater understanding and to nourish pluralism in America. Since 2006, UPF also has worked in Hollywood, and in 2008 established its MOST Resource Center, providing free resources and expert advice to the makers of television programming. It accomplishes its goals by forging partnerships with major U.S. educational, civic, and philanthropic institutions and by working with leading feature film and television producers and writers.

Going into its thirteenth year, UPF has now produced nine films, with several films in development. Films produced range from traditional long-form historical documentaries for television such as *Muhammad: Legacy of a Prophet* (2002), *Cities of Light: The Rise and Fall of Islamic Spain* (2005), and *Prince Among Slaves* (2006), to contemporary one hour bio-docs such as *On a Wing and a Prayer* (2007) and *Talking Through Walls* (2008), to the data-driven policy documentary *Inside Islam: What a Billion Muslims Really Think* (2009) to *Islamic Art* (2011), a review of centuries of civilizational artistic production.

Films produced in 2011 include the 2-minute *My Fellow American*, which was UPF's first film distributed exclusively online and via social media for a mass audience; and a full-length documentary about the great art and architecture of the Islamic world made for broadcast on public television, *Islamic Art. Mirror of the Invisible World* (www.islamicart.tv).

In 2012, UPF announced its latest project: *All That Remains: A Story of Muslim Heroism from World War II*. The three parts of this project include a documentary film, a companion website, and a multiple-part educational outreach effort. The production is projected to come to completion by the end of 2013.

All of UPF films have been broadcast locally and/or nationally on PBS. In 2008, UPF placed its first full-length film in theaters around the country, a stand-up comedy performance movie called *Allah Made Funny* (2008). Each of UPF's films has won one or more national awards, such as Best Documentary at the American Black Film Festival, and awards from World Media Film Festival, Media That Matters, Cine Golden Eagle, Grand Goldie, Telly awards, and Communicator Awards, as well as "craft" awards for best direction, writing, editing, musical score, set design, lighting, and voiceover, among others.

Nature of the Foundation (continued)

In 2012, UPF's educational websites (such as <http://islamandcivics.upf.tv/> and <http://campus.insideislam.tv/>) continued to provide hundreds of teachers with free UPF films and resources such as lesson plans to facilitate dialogue in schools.

In the same year, UPF also partnered with the American Library Association in support of their project entitled "Muslim Journeys Bookshelf" bringing two UPF films, *Prince Among Slaves* and *Islamic Art* to 1,000 libraries across the country.

Altogether, over 1,000,000 people have participated in UPF outreach efforts and over 20,000 dialogues and public programs have been held, to date.

MOST Resource

UPF's *Muslims on Screen and Television Resource (MOST Resource)* is a research and resource service located in Hollywood to provide writers and producers of TV and film timely and accurate information about Muslims, Islam, and peoples living in Muslim majority countries around the world. *MOST Resource* gives writers and producers complimentary access to the accurate research, information, experts and Muslim community members that inform and reflect characters and storylines they hope to develop.

As Muslim and Middle Eastern themes and characters appear more often in television and film, writers and producers face a complex challenge: presenting multidimensional characters and stories with authenticity and accuracy. To address this challenge, after two years of needs assessments among the Hollywood entertainment community, UPF, in partnership with the Saban Center for Middle East Policy at the Brookings Institution, Gallup Organization and the Muslim West Facts Project, launched *MOST Resource* in October of 2008.

Based at the University of Southern California's School of Cinematic Arts in the Steven Spielberg Building, *MOST Resource* also engages thought leaders and the entertainment community in an on-going dialogue about the relationship between the United States and the Muslim World; the experience, culture and lifestyles of Muslim and Middle Eastern Americans here at home; and the impact of entertainment on U.S. relations with the Muslim World and Western-born Muslim and Middle Easterners.

Because TV shows and films reach millions of homes and people worldwide, UPF intends, by helping Hollywood professionals create more authentic, accurate and diverse depictions of Muslims and Middle Easterners, to exponentially expand its U.S. and global impact on understanding, peace and security.

Nature of the Foundation (continued)

UPF's films are used in corporate and government offices, universities and schools, community and faith-based organizations, museums, and living-room dialogues in every state of the U.S. News media outlets, including YouTube and online media distributors, online sales platforms such as Amazon and iTunes, and social networking websites such as Facebook also connect people to UPF films. As media technology expands and changes, UPF continues to seek ways to reach, create and transform new audiences.

UPF's educational mission is carried out at the community and national levels through its Outreach programs and campaigns, most notably *20,000 Dialogues*, and its resource center for the Hollywood creative community, *MOST Resource*.

UPF Outreach and 20,000 Dialogues

UPF's outreach effort consists of a series of national programs and campaigns that use UPF films to help increase understanding of Muslims and Islam. UPF's flagship outreach program, *20,000 Dialogues*, equips educators, civic and thought leaders, and everyday Americans to use UPF's films to start dialogues about Islam, and to foster relationships between Muslims and others. *20,000 Dialogues* employs online marketing and partnerships with national organizations to engage teachers, students, non-profit leaders, members of churches, synagogues, temples, and mosques, policymakers, government officials and the general public. These groups conduct small- and large-scale dialogues using UPF films and downloadable lesson plans and discussion guides.

Based on its experience with *20,000 Dialogues*, over the last year UPF has expanded its outreach to new audiences and has developed innovative ways to reach them. UPF's arts and humanities programs include the National Endowment for the Humanities-supported public program, *Prince Among Slaves. The Cultural Legacy of Enslaved Africans*. UPF's program *Understanding Muslim Diversity. Security and Policy Implications* works with agencies such as the U.S. Department of Justice, the FBI, the U.S. Department of Defense and the U.S. Department of State to raise awareness of racial profiling and to encourage internal discussion in these agencies on balancing civil rights for Muslims with national and local security.

UPF's first national social media campaign to share the untold stories of Muslims in America, called "My Fellow American," received over 1 million views on its YouTube channel in 2012. This followed the previous year's campaign "Ground Zero Dialogue" to encourage dialogue about the "Park 51 Community Center controversy" in lower Manhattan. Both social action projects seek to create an online community dedicated to promoting greater information and education about American Muslims.
