


Primary Exempt Purpose: To promote women's physical and mental health, education and empowerment, especially women living in conditions of poverty in politically and economically marginalized or underserved communities or other women who face similar challenges. The corporation may also promote the health and education of children and men in so far as the health and education of children and men impact the health, empowerment and well-being of women.

Part III - Line 28

The Midwife Program in Matagalpa, Nicaragua Expenses: \$58,633

The work of the Midwife Program is prevention: to educate women, families, youth and community members, to help women avoid unwanted pregnancies, to recognize potential reproductive health problems, and to refer women to health facilities before serious problems develop. Women at risk for problems during birthing are encouraged to give birth in health facilities. Traditional midwives and community health workers are trained by mentors who are nurses from health centers serving the communities. Teaching courses, regular meetings and on-going relationships of accompaniment, mentoring, and friendship provide support to midwives as they continue, as they have throughout history, to attend low-risk births.

Speaking Tour Expenses: \$ 5,446

The project supported travel for the Director of Nicaragua Midwifery Education Project to travel to various locations throughout the United States to participate in education and fundraising events in the spring of 2012. The primary purpose of the tour was fundraising for the Midwifery Program.

Newsletter Expenses: \$ 3,690

The Newsletter is a periodic publication which describes the programs supported by the Women's Empowerment Network. It is sent to 2,000 individuals across the United States.

Part III - Line 31

Kawah Ijen Expenses: \$ 576

Through showings of the documentary film, Where Heaven Meets Hell, funding is raised to improve the quality of life for families who work in the sulfur mines at Kawah Ijen, an active volcano in East Java, Indonesia. The project currently provides books for area children, a small lending library, and gas masks for miners; additional projects will be added based on community needs and the availability of funding.
