In the last year Point of Distribution workers were able to provide basic HIV prevention supplies, hygiene supplies, food, water, blankets and other essentials to 3639 participants per week. In Oakland, POD was able to provide 125 HIV antibody tests. 28 POD participants reported successful use of overdose prevention materials provided during street education sessions.
