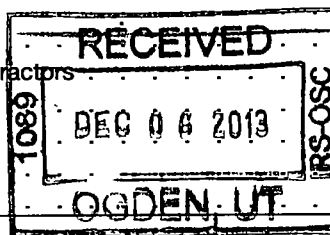




Part III, Line 28 ---The Dollars For Your Thoughts engaged 100 Sunflower County, Mississippi middle and high school students in 5 weekly workshops for 6 hours per week and in dialogue and conversations about their present circumstances and their outlook for the future.

These dialogues included discussions about health, education, race, social interactions, and healthy relationships. The conversations entailed demonstrating how our thoughts and feeling about our present circumstances and our outlook on life determines what our future will look like. The workshops also helped students to align their unique strengths, talents, gifts, and greatest passions with a clear vision for their future. The intention of the project was to inspire youth to take purposeful action in the present so that they can create a life of great fulfilment for the future. One of our goals is for the students completing the program to have a positive impact on their peers and on the Mississippi Delta. We also engaged 60 students from the 2012 completion group in alumni meetings and community service projects, as well as, continuing dialogues. Additionally, we provide a summer program to Pre-K through 5th grade, where we teach reading and health for 4 days a week for 5 weeks.
