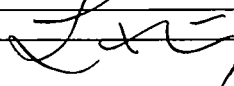

Placement of children: In 2012, 478 orphaned children (up to fourteen years of age) from the People's Republic of China and Haiti were placed in American adoptive families. An additional 336 families had applied and were in various stages of the adoption process. These stages include: applications, home study, compilation of dossier, translation, child match by the Chinese and Haitian Governments, and post adoption supervision. At 12/31/2012, 2210 families were in the adoption process.

4b (Code:) (Expenses \$ 656,470 including grants of \$) (Revenue \$ 797,601)

Childrens Charity Fund: a restricted fund dedicated to humanitarian assistance to orphanages. The fund has been used to purchase food, clothing, education materials, toys and medical assistance. CCC has developed 7 Orphan Care Centers in Zhejiang, Hunan, Chongqing, Nanyang, Luohe, Zhengzhou and Kaifeng; Henan, caring for 300+ children. CCC developed a foster sponsorship program for children under the age of 13 living with foster families in China. CCC sponsored 500+ foster care children awaiting adoption.

4c (Code:) (Expenses \$ 331,543 including grants of \$) (Revenue \$ 209,229)

Family Development Services: To ensure the success of the adoption, CCAI developed post adoption services designed to assist families in the bonding process, cultural and interracial difference. The Joyous Chinese Culture Center conducts programs for pre-school through elementary school to teach the Chinese traditions and to overcome issues associated with adoption. More than 400 children and their families have participated in these activities.
