Public Policy - Our public policy initiatives ensure that conservation finance incentives in Colorado remain in place. These incentives are the primary conservation tools used by land trusts and local government open space programs and have resulted in nearly 200 million acres protected in Colorado. These goals have been met through broad based coalition building, including representatives from agriculture, recreational and environmental interests.

4b (Code _____) (Expenses \$ 176,796 including grants of \$ _____) (Revenue \$ 40,244)

Education - CCLT conferences, publications and newsletters reach thousands of people throughout Colorado who are involved in the preservation of Colorado's open space heritage. Our annual conference is attended by approximately 250 people including conservation professionals (lawyers, appraisers, realtors and land trust personnel) as well as landowners. This state-wide policy conference features training sessions by experts in the field. In recent years, CCLT has published guides on phasing conservation easement transactions, appraising conservation easements, mineral rights and conservation easements, and on funding opportunities for open space projects.
