





Organization's primary exempt purpose:

The Tibetan Children's Education Foundation is a nonprofit corporation founded in 1995 and dedicated to the preservation of Tibetan culture by supporting Tibetan schools and school children in exile from their homeland.

Description of Achievements in Carrying Organization's Exempt Purpose

Cultural Tour 2012

One of the major aims of our Foundation is to help preserve Tibetan culture by raising awareness of this unique culture here in the West. Towards this end, the foundation invites Tibetan cultural ambassadors to share their art and culture with interested audiences here in America.

This year we did three major Tibetan sand mandala presentations with the Ven. Ngawang Chojar - master Tibetan sand mandala creator. We did events at Billings, MT, Helena, MT and Seattle, WA.

Major expenses for this year's Tibetan sand mandala tour included travel, boarding, lodging for the artists and accompanying staff during the tour. Major income from the tour came from donations to our general fund and funds for the sponsorship programs.

Children's Sponsorship Programs

Kyitsel-ling Sponsorship Program: Individual sponsors contribute \$25 to \$45 a month to support the education of needy Tibetan children staying at Kyitsel-ling Tibetan Children's Education Center in India. Kyitsel-ling provides board, lodging and meets all school related expenses with this sponsorship money.

Kyitsel-ling Outreach Sponsorship Program: Individual sponsors contribute \$25 to \$45 a month to support the education of needy Tibetan children outside Kyitsel-ling that are supervised by Kyitsel-ling.

For the children's sponsorship program, this year we began collaborations with the Central Tibetan Administration (CTA) Dharamsala, India. Operating on our previous model, sponsors contribute \$35 to \$45 a month to sponsor Tibetan children through the Tibetan Children's Education & Welfare Fund (TCEWF) under the CTA and also through Sambhota Tibetan Schools Society that runs many of the key Tibetan schools in exile.

College Sponsorship Program: Many of the children who received their school education through our sponsorship program are now graduating high school. The TCEF board decided to make efforts to support the college education of the brightest of these. The beneficiary of this sponsorship was again selected by a selection committee headed by the Director of Kyitsel-ling Tibetan Children's Education Center, N. India on the basis of merit and need. Sponsors contribute between \$800 to \$1000 a year to sponsor the college education of Tibetan children in need.

This year's College Sponsorship Program included our first student here in the United States. Lhamu is currently studying at Carroll College, Helena, MT and TCEF in collaboration with another non-profit called A Hundred Friends is sponsoring her education.

Grandparent's Fund:

Living stipends for Elderly: This is an effort to help elderly Tibetans living in exile (mostly in India) in need - those who are sick, those with no children or other family members to provide for them etc. Individual sponsors contribute \$25 to \$35 a month to support these elders in need.

Other Programs:

Dhondupling Tibetan School Computer Project

TCEF helped to provide the first computers for this Tibetan school in Clement Town, N India in 2003. As a result, Computer Education is already a part of this school's curriculum. Unfortunately, those computers were now old and did not work properly. This year, we got a grant to provide 20 new computers to this school.

Lunch Program, Yuksom Sikkim

Dubdi Monastic School is located in Yuksom Village western Sikkim, India. TCEF began a lunch program for this small monastic school in 2008. There are between 24-30 young monks from very poor families receiving their education here. This monastic school is a one room schoolhouse with no electric and no heat. There are few books that are shared between all the children and each child has only one thin notebook and they use their pencils down to tiny stubs. The lunch project for the monks in Yuksom continued in 2012.

Kyitsel-ling Dance Drama and Music Project

One of the major goals of Tibetan education in exile is to help transmit the Tibetan culture to the children. One way the Tibetan schools do this in India is by having Tibetan Dance Drama and Music as part of the school curriculum. Kyitsel-ling Center that TCEF helped to found also has this Tibetan Dance and Music Program. In order to help these classes be successful, at the request of Kyitsel-ling, TCEF funded \$4,500 to purchase Tibetan musical equipments and Tibetan Dance and Drama costumes.

TCEF Service Trip Programs 2012

TCEF invites interested individuals with skills to teach and empower those we serve on yearly Service Trips. These trips go to the TCEF service sites in India and do hands on projects. The service trip fee includes the cost of the projects selected that year and the cost of ALL in country transportation, food and lodging.

The 2012 Service Trip projects focused on Basic School Nurse Type Health Assessments including height, weight, vision, hearing, dental and general health observations. It included the creation of medical records for each child. This service trip also included vocational carpentry, soap making class, English language proficiency training (teacher to teacher), dental hygiene classes with puppets, tailoring, and art. The 2012 trip had 14 participants including a TCEF project manager and a TCEF board member as assistant to the project manager. The trip was 46 days and 28 were direct service days and 8 days were travel days to or from service sites.
