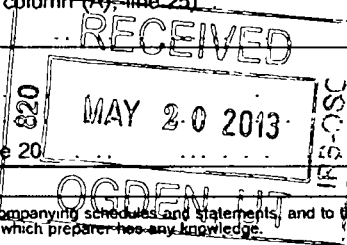

In 2012, SSPRC began the complex process of becoming a medical office, offering limited obstetrical ultrasounds and pregnancy tests with a medical diagnosis. By the end of 2012, this process was well underway, with an expected completion date of May 2013. Also, in 2012, SSPRC staff received extensive training on legal, ethical and medical components of the medical conversion. SSPRC remodeled its office to accommodate medical equipment, purchased an ultrasound machine and changed its software programs to comply with legal requirements.

4b (Code) (Expenses \$ 5,961. including grants of \$ 0.) (Revenue \$ 0.)

Parenting Education: Approx. 150 individual clients participated in free parenting education courses. In conjunction with mentoring to encourage positive parenting skills, clients received material resources as an incentive through the education program, allowing them an opportunity to meet the material needs of their growing families in a way that affirmed their personal dignity. SSPRC provided more than a dozen cribs and car seats to parents who invested more than 25 hours receiving education, mentoring and affirming their parenting skills.

4c (Code) (Expenses \$ 2,746. including grants of \$ 2,000.) (Revenue \$ 0.)

SSPRC provided pregnancy counseling to approx. 30 women, who received free pregnancy tests and options counseling. SSPRC awarded two scholarships of \$1,000 each to two young women. Each client who received free pregnancy tests and options counseling also spent time with trained peer counselors who assisted them in completing an objective plan assessment. Our peer counselors advocate for clients in emotional, mental, spiritual and physical terms, encouraging their optimum long-term health. The Lovin' Life scholarship was launched in 2012, encouraging young people to consider the value of their lives and their life plans.
