Art Projects: During 2012, Working Classroom's Visual Arts Program provided tuition-free professional Visual Arts training to 89 aspiring student artists from historically ignored communities resulting in two art exhibits-an installation at Working Classroom and an exhibit at the Wheels Museum in Albuquerque and two public art projects-a video installation in the Albuquerque Convention Center and a landmark mural on a health center serving a low income community.

4b (Code:) (Expenses \$ 209,181 including grants of \$ 0) (Revenue \$ 148,664)

Theater Projects: During 2012, Working Classroom's Theater Program provided tuition-free acting instruction to 83 aspiring student actors from historically ignored communities, sponsored two productions and toured one to northern New Mexico. My Heart Hurts, an original performance piece, was commissioned for Windows and Mirrors, a nationally touring exhibit sponsored by the American Friends Service Committee and was performed at St. Michael's and All Angels Episcopal Church and the Albuquerque Center for Peace and Justice. The second production opened in Working Classroom's Paul Carpenter v Salazar Theater and toured to Northern New Mexico College in Espanola.

4c (Code:) (Expenses \$ 31,269 including grants of \$ 11,595) (Revenue \$ 19,657)

In 2012, Working Classroom provided academic tutoring and professional skill building opportunities to over 172 students, provided paid internships to 20 aspiring artists and actors, and a full-tuition college scholarship to one student and partial scholarships to five others.
