Lone Tree Ranch is a camp developed and designed for 13-18 year old youth. This program centers around outdoor activities. Bible lessons are taught to the campers using the activity as an object lesson. Evening chapel times are centered around challenges children face each day with solutions based on Biblical principles and concepts. Through the use of our high ropes course, children are taught valuable principles and life lessons that they can take back with them to school and help them prepare for their career and life goals. Children are taught how to communicate, set goals, solve problems, conflict resolution, and work as a team. Children are encouraged to grow in their relationship with God and with each other. This achievement code also includes other program expenditures.

4b (Code:) (Expenses \$ **311,745** including grants of \$) (Revenue \$)
Fort Lone Tree is a camp developed and designed for 8-12 year old campers. Campers at Fort Lone Tree are given the opportunity to enjoy God's creation and the outdoors. Bible studies are taught during each activity and around the campfire each evening. Children are able to try new activities and develop new skills. As campers return to camp, training programs are available to them that introduce them to responsibility and teamwork. Campers are given the opportunity to serve others and live out their Christian faith. As campers progress they are given more responsibility and develop leadership skills. Campers are taught how to communicate, solve problems, set and plan goals, all from a biblical perspective. Many campers return to be a part of summer staff when they become of age.

4c (Code:) (Expenses \$ **103,679** including grants of \$) (Revenue \$)
Lone Tree Missions is a program designed to give high school age children a chance to serve others less fortunate than themselves. The current program offered is on the Alamo Navajo Indian Reservation. Projects include replacing leaking roofs, repair stucco walls, replace broken windows and yard clean-up. The children contribute the money needed to buy the materials and the children do the actual work under the supervision of several Lone Tree staff. The children live in simple quarters, sleeping on mattresses on the floor, and work together to prepare their own meals and clean-up. These projects are an incredible way to get children to serve others while realizing how much we have all been blessed with and often take for granted.
