In 2012, GCY celebrated its 14th year of service. The program season runs from March through August. During that period in 2012, GCY facilitated 38 river education programs, serving 654 participants from across the country & internationally on 3,438 participant days. Trip programs took place on five sections of rivers & canyons in Utah and Arizona, including the Grand Canyon. The GCY program continues to be one of the most affordable programs of its kind, charging up to two-thirds less than commercial river trips. Participants paid only 42% of the actual cost of operating the programs in 2012, the rest was funded by grants, contributions and special events. Additionally, over \$27,500 of financial aid was awarded to 39 participants during the year. Participants engaged in nearly 10,000 hours of community service during 2012, were required to earn a portion of the cost of their trip and presented educational projects of their choice related to the cultural or natural history of the Southwest. (continued from above) The warehouse and office is based in Flagstaff, AZ. GCY also facilitates 3 service-learning clubs at local schools where students assist in the planning & implementation of community service projects throughout the year. GCY has forged strong partnerships with Grand Canyon National Park, the U.S. Geological Survey, local tribal nations, the Grand Canyon Trust, the "I Have a Dream Foundation" in New York City, and many schools and youth organizations. In 2012, GCY completed implementation of three science initiatives: natural sound, water quality & visitor impact monitoring, where participants worked closely with scientists to gather & analyze data during program trips. In 2012, GCY collaborated with the National Geographic Society on a trip with youth nationwide exploring cultural history & photography in Grand Canyon. The annual "Grand Inspiration" trip included youth involved in the visual arts, photography and creative writing. This year was also the fifth year for a river program that brings together (continued below)

(continued from above) low-income youth from Philadelphia with youth from Flagstaff. The Native American Youth Artist program continued in 2012 with acclaimed Navajo artist Baje Whitehorse leading students in daily art workshops. A new relationship and trip was launched with the Mighty Quapaws, a group working with underserved youth in Arkansas along the Mississippi River, who contrasted it with the Colorado River. GCY continued to receive excellent post-trip reviews from participants and their parents, 100% of whom would recommend GCY to others and believed that GCY provided the participant with a educational experience, and that the community services was a valuable part of the program. The focus of its programs & trips continued to be not only the educational & community service curriculum, but valuing the teachable moments along with river, where learning is not an abstract concept but something real & hands-on for students.
