	DURING THE PAST YEAR, JEWISH FAMILY SERVICE (JFS) HAS CONTINUED TO EXPAND PROGRAMMING TO MEET THE NEEDS OF THE COMMUNITY. OUR FOOD PANTRY SEEMS TO HAVE RECEIVED MUCH MORE USE THIS PAST YEAR. WE CONTINUE TO OFFER SERVICES IN THE PARK CITY AREA AND IN JUNE WE INITIATED A NEW PROGRAM - LIVEWELL - WHICH ASSISTS WOMEN DIAGNOSED WITH BREAST CANCER AND THEIR FAMILIES. EXISTING FOUNDATION FUNDING HAS REMAINED FAIRLY STABLE, BUT NEW SOURCES OF FUNDING HAVE BEEN VERY DIFFICULT TO ENGAGE IN THIS ECONOMY. JFS HAS STARTED AN AFFINITY GROUP WE CALL THE CHAI SOCIETY FOR DONORS WHO COMMIT A MINIMUM GIFT OF 1800 A YEAR TO THE AGENCY. THIS WAS AN EFFORT TO MOVE SOME OF OUR MOST CONSISTENT AND MAJOR DONORS TO A NEXT LEVEL. SO FAR, WE HAVE 21 MEMBERS. REQUESTS FOR SERVICES, ESPECIALLY FINANCIAL ASSISTANCE CONTINUES TO GROW AND THIS PAST YEAR, WE RECEIVED SOME ADDITIONAL FUNDING FROM UNITED WAY OF SALT LAKE TO HELP WITH OUR EMERGENCY ASSISTANCE. COUNSELING AND CARE MANAGEMENT CONTINUES TO BE THE PRIMARY SERVICE JFS IS DELIVERING TO THE COMMUNITY. WE ALSO CONTINUE TO HAVE A VIBRANT VOLUNTEER PROGRAM AND PROVIDE VERY WELL RECEIVED COMMUNITY LECTURES. JFS IS PARTICIPATING IN A JEWISH COMMUNITY PROJECT TO PROMOTE LEGACY GIVING.
