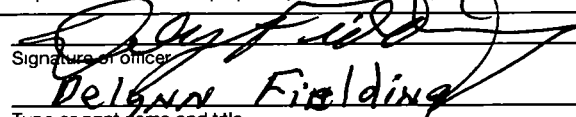

During calendar year 2012, our Business Expansion and Retention Project visited 926 companies in our area, and provided help and referrals to assistance 285 times. This effort provided direct cash benefits to the businesses of \$246,090 with an increase of company revenues reported by the business of \$327,000. The companies leveraged \$1,527,000 in private investment in new plant and equipment with an additional \$13,300 of local revolving loan funds. Report cost savings to the companies is reported by them to be \$239,850 and \$135,000 increase in revenues. The companies reported 14 jobs created and 42 jobs retained. This year we helped support the program in 16 other counties in Utah.

Carbon County Boys and Girls Club were able to find four major donors who contributed funds to buy a 'club house'. We were their funding conduit for this fund raising effort. Currently they are refurbishing the facility and hope to have it in service this summer.

Utah State University - Eastern raises scholarship funds from our outreach efforts and payroll deductions. All raised funds go directly to the scholarship fund with no overhead or expense.
