Grants to Benefit Needy in General - Haiti - Clean Water Reiser Relief, Inc cooperated with Healing Haiti in a program designed to provide clean water to the poor in Haiti Under this cooperative program, Reiser Relief, Inc provided grants to Healing Haiti, which Healing Haiti used to operate a water truck that delivers 364,000 gallons of clean chlorinated drinking water every month to the poor in the slum of Cite Soleil, Haiti During 2012, an additional water truck was transported to Haiti This program delivers loads of water 6 days per week, 52 weeks per year, to thousands of families Funds support local Haiti driver salaries, fuel and maintenance The number one cause of malnutrition being a lack of clean water, this program brings life saving water daily to those in need Healing Haiti a publically supported 501c3 organization, located in White Bear Lake, MN, that provides help to the poor, the vulnerable, and the
