CityKid Cafe: Fill a bag, feed a child. At the CityKid Cafe, volunteers prepare and deliver food to deliver to several neighborhoods
of Amarillo. Over 1,000 lunches per day, Monday through Thursday are delivered. Volunteers and Citychurch staff prepare each
lunch. The lunches consist of a hot item, fruit, cookies, and popcorn. The bags are loaded in trailers and delivered by van or by
bicycle to the neighborhoods where Citychurch concentrates its ministry. The lunch is usually met with a smile and excitement
from the child or teen who receives it. The children who receive the lunch begin to look forward to it and depend on it.
Citychurch also host summer mission groups. Each year Citychurch hosts over 700 missionaries and volunteers who come to
learn about ministry in the inner-city. Lunches are also fed during spring break and some school holidays. CityKid Cafe's bike
delivery program has grown. It is a fuel saving, fun, environmentally friendly way to take children their lunch during the summer.
CityKid Cafe also helps facilitate the Snack Pak 4 Kids program that gives school age students a backpack full of food for the
weekend and feeds the children of Citychurch Academy.

Citychurch has a Sunday worship service for children and families. Vans pick up children for breakfast, children's classes,
hosts the Jesus Loves You Celebration. It is a citywide crusade with preaching, music, food, and fun. Hundreds are fed and
ministered to. Citychurch also sent workers on a mission trip to Chad in Africa in October of 2012. The workers went to help
facilitate a medical outreach while concentrating on meeting physical and spiritual needs of the children they came in contact
with while in Chad.

Citychurch has a youth program to reach junior high and high school aged children in the disadvantaged neighborhoods of
Amarillo. Youth are picked up from the middle school and high schools once a week and brought to the church for meals, music,
games, and Bible study. Each year, Citychurch takes the students on a summer and spring retreat to get them away from the
pressures of the inner-city.

Citychurch has many ministries to children. During the fall and spring semesters, Citychurch has a weekly afterschool night. Children are met at or near their school. The program begins with a snack and ends with sack dinner to take home, and in between are activities, crafts, and games. During the summer months, children are brought to our park for Bible lessons, games, lunch, snacks, and crafts. Each week of the summer, different neighborhoods are targeted for the week long Bible club. Citychurch also fills the visible needs of the children that we minister to, including back to school needs. Citychurch also delivers custom packed Christmas boxes to all children and youth involved in our ministry. The boxes include a blanket, toys, hygiene items, socks, underwear, and candy. This year Citychurch supported and facilitated the Camp Hope (formerly Angel Tree Camp) ministry, a camp for children involved with Citychurch and children who have incarcerated family members.

The goal of the television and internet ministry is to inspire others to reach out to the hungry and lost children of their own city. The documentary style programming offered on television program and streaming on the internet shows how to help others in need. The message of the show is an outreach to people who cannot attend Citychurch because of geographic location, financial situation, or disability.

Citychurch Academy is an early education center committed to a strong Biblical education. Students are given a tuition free Christian education. At Citychurch Academy, students receive a broad spectrum of fun and educational opportunities including music, art, physical education, and field trips. Citychurch Academy will give young minds a jump start to reading and continuing their educational journey.
