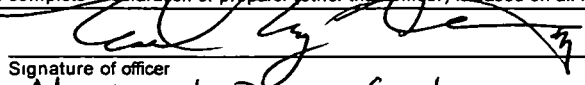

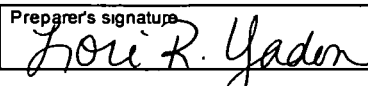

IN 2012 BREAD OF LIFE WAS ABLE TO ADD 2 NEW LOCATIONS FOR DISTRIBUTION WHICH ENABLED THEM TO GIVE GROCERIES, TOILETRIES, AND OTHER ASSISTANCE TO OVER 7,000 INDIVIDUALS, MANY OF WHOM RECEIVED ASSISTANCE MONTHLY. OVER 22,000 CASES OF FOOD AND DRINK PLUS AN ADDITIONAL 60,592 POUNDS OF GROCERIES WERE DISTRIBUTED THROUGHOUT THE YEAR TO THE INDIGENT POPULATION IN SAN JOAQUIN COUNTY.
