Inpatient Services - Ti Kay, Inc supports the provision of nursing care, oxygen, food and medicines to its patients. Donations and grants are used to purchase food, oxygen, medicine, transportation and hospital equipment for patients. Ti Kay, Inc works with approximately 40 different programs to acquire donated medicines for the clinic. While certain amounts of medicines are donated, the needed amounts are not always regularly available through donations only and therefore funds are also used to purchase any additionally needed medication. Ti Kay, Inc also administers a range of diagnostic, clinical management and support services, when a patient first arrives at the clinic, that patient is given a chest X-Ray and his or her oxygen level is checked. Prescriptions are given based on

Outpatient Services - Ti Kay, Inc has developed a system for helping patients adhere to their medication programs because consistently taking the prescribed medicines is essential in treating tuberculosis. Ti Kay, Inc's system involves former patients regularly calling current patients as a reminder for them to take their medications. The ex-patients are provided with small laptops, telephones and given a small amount of transportation money in order to stay in contact with the new patients receiving treatment. Ti Kay, Inc also provides testing of the general population for TB, HIV and other infectious diseases. In addition, Ti Kay, Inc seeks to educate the patients regarding issues such as the importance of treatment adherence and the public health impact of these diseases. Upon release from

School Fund - Ti Kay, Inc provides fund to pay school expenses for children whose education are not funded because they have HIV or because they lost a parent to HIV or TB. The original form 990 filed failed to report \$2,376 of the contributions received (line 8), -\$2,988 of grants paid (line 13), and \$22,261 of expenses paid (line 17). Therefore, the original fund balance (line 22) was overstated by this \$16,897 difference. The original bank balance was also overstated by the same amount.

Out of the total program expenses not previously reported, \$13,082 was related to inpatient services (part III 4a), \$8,721 was related to outpatient services (part III 4b). The prior school fund expenses were overstated by \$2,988 and the management & general expenses were increased by \$458. The amended return correctly reports these corresponding changes.
