Pacific Lumber Inspection Bureau provides supervisory quality control services for structural dimension lumber and other specialty lumber products under the various lumber grading rules used in the Pacific Northwest regions of the U.S. and Canada. This includes lumber grade stamping, grade certificates and grader training and certification. Services are offered at cost to primary lumber manufacturers, remanufacturers and the general public. PLIB also provides heat treating (HT) certification and HT stamping services for sawmills, dry kilns and remanufacturers under the authority of USDA, APHIS, ALSC, CLSAB and CFIA. The Bureau also provides inspection and quality marking services to ISPM 15 compliant export wood packaging through its Wood Packaging Materials (WPM) program. Pacific Lumber Inspection Bureau also publishes and distributes the "Export 'R' List Grading and Dressing Rules" for export lumber.
