Providence St Peter Hospital offers a wide range of services that provide health benefits to the uninsured and underserved in Southwest Washington community These services, most of which do not generate enough income to support themselves, include programs such as psychiatry, chemical dependency, a sexual assault clinic, and a pediattrcs unit, free and low-cost health screenings and education events, support services for cancer patients, survivors and their families, and medical training and career development for current and future medical professionals Providence St Peter Foundation supports these services by developing and receiving philanthropic resources from the generous individuals and businesses within the community In 2012, with these donations, the Foundation was able to provide over \$300,000 to fund the acquisition and upgrade of such necessary equipment as vital sign monitors, video scopes, patient lifts, pediatric cribs and a heating/cooling system for the Hospital's cardiovascular operating room The Foundation was also able to provide over \$100,000 to fund psychiatric resources and services, animal-assisted therapy, assistance to employees facing financial hardships and bedside companionship and grief counseling for dying patients and their families The Foundation also funded over \$90,000 in continuing education and medical training activities for palliative care and hospice professionals, nurses and nurse technicians, and other medical personnel The Foundation also supported various improvements throughout the hospital, such as the purchase of new furniture for waiting rooms, patient areas and conference rooms, maternity supplies and towels, sweatshirts and sweatpants for patients

The population of Thurston County has grown by 22% over the last ten years Providence St Peter Hospital(PSPH) has seen admissions grow at a similar rate Thurston County has been one of the fastest growing counties in Washington State Due to population trends, PSPH can no longer accommodate the demand for in-patient admissions The expansion project benefits the entire hospital as these beds can be used for many levels of care The project funding was from a variety of sources including, debt financing, hospital operating budgets, and generous philanthropic support from the community Hospital leadership and foundation support made a new Critical Care Unit (CCU) possible and it opened in October of 2012

Providence SoundHomeCare and Hospice brings the Providence tradition of excellence into the home setting Their goal is to provide the highest level of service in a caring and responsive manner The home care and hospice teams work together with physicians, patients, family members and insurance providers to meet each patient's unique needs Access to its professional services is available 24 hours a day, every day Serving Mason, Lewis and Thurston counties, Providence SoundHomeCare and Hospice is a non-profit, state licensed and Medicare certified agency Foundation funding helps with respite care, comfort therapies, grief support, and education

The Sexual Assault Clinic is part of Providence St Peter Hospital in Olympia It serves residents of Thurston, Lewis, Mason, Grays Harbor, Pacific and Wahkiakum counties The physicians, nurse practitioners, nurses and social workers provided special medical evaluations for children, adolescents and adults Patients and their families are then referred to community agencies for counseling and other services The Sexual Assault Clinic is a certified specialty services provider The Washington State Crime Victims Compensation Program pays for some of the associated expenses for the medical evaluations Patients or their families will not be charged Victims of an assault that occurred within the last 96 hours should be seen at a hospital emergency room The sexual assault nurse examiners are on call to the Providence St Peter Hospital emergency room

Every year, St Peter Foundation holds a special event called Christmas Forest As part of this event, a request for contributions toward a specific "Fund-In-Need" is made In 2011 the focus for this "Fund-In-Need" was for telemetry in the hospital's new Critical Care Unit These funds along with others from the Foundation's Greatest Need Fund, helped the hospital purchase the telemetry needed during 2012

Providence St Peter Chemical Dependency Center has been a chemical dependency provider since 1986 The Center offers a complete continuum of treatment options to diagnose, treat, and provide ongoing recovery support to individuals and families whose lives have been affected by the harmful use of alcohol and other drugs Its medically supervised programs offer excellence in clinical counseling, comprehensive education, and a safe environment for recovery The Chemical Dependency Center is licensed by the State of Washington and is approved by The Joint Commission Its treatment model incorporates the nationally recognized American Society of Addiction Medicine (ASAM) placement criteria, family involvement, and community-based recovery support groups In 2012, the Foundation provided funds to this program to support staff training and conferences, educational materials (such as drug cessation books and DVDs) for clients and supplies for tobacco cessation treatment

Funds raised by the Foundation to support the trauma service line supported the purchase of a portable ultrasound system

Providence Mother Joseph Care Center (MJCC) is a Catholic, non-profit facility committed to improving the care and quality of life for the elderly and chronically ill MJCC provides high-quality care with an emphasis on respect for the cultural and spiritual diversity of those it serves The employees, volunteers and medical staff recognize the dignity and value of each individual MJCC provides sensitive, holistic care to meet the physical, spiritual, social and psychological needs of each patient Foundation purchases included a shower installation, new mattresses, oxygen concentrators, and funds for staff education

The following paragraphs provide further information about the process we use to determine compensation for top management, officers and key employees.</p> <p>Providence has a single fiduciary Board, with responsibility for financial oversight associated with fulfillment of the Providence Mission, developing system policies, protecting the assets entrusted to the organization and overseeing the strategic and operational affairs of Providence's legal entities. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its employees, including our senior executives. Salaries for senior executives are determined by the Providence Board's Human Resources Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee.</p> <p>Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles &amp; advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. Applying the above principles, the salary review of the Foundation Executive Director is handled annually through the WA/MT Regional HR office.</p>
