Nutritious meals are available for qualified clients through collaboration with Chicken Soup Brigade.

PCAF provides primary prevention programs to gay and bisexual males in Pierce County, as well as prevention case management for people who are HIV positive in Pierce County. More than 500 at-risk gay and bisexual males were reached.

The Oasis Youth Program served more than 400 gay, lesbian, bisexual and transgendered youth, ages 14-24 at its drop in center. Oasis provided a variety of health and safety services. Services included HIV prevention, violence prevention and victim's advocacy. Oasis also provides anti-bullying, both in and out of school settings.
