To support these efforts, we produced and distributed the following research reports: Medicaid Matters to Idaho; Predatory Lenders Trap Idahoans in a Cycle of Debt, The Cost of Cuts, Fixing the Foundation in Colorado, Promises To Keep: The Importance of an Inclusive Family Unity Waiver; The State of Health Care Reform, How Money in Politics Affects the 99%... And How the 99% is Fighting Back, Keeping the Fox Out of the Health Care Henhouse, and Invest in a Healthy Idaho. We distributed our reports on our website, at public events and community forums, at press release events, and other methods. In addition we continued to work with partners in the Health Rights Organizing Project network and assisted state based groups with their economic and racial justice campaigns

NEW BOTTOM LINE. NBL focused its organizing and communications energy into winning the fight for hundreds of billions of dollars in principle reduction for underwater homeowners. Resetting mortgages to fair market value to avoid foreclosures, known as principle reduction, would provide relief to millions of homeowners, put more than a billion dollars back into our communities, and create more than 1 million jobs a year. NBL launched 2 successful creatives to lift up key narratives around principle reduction. We played a key leadership role in the 99% Power shareholder season, targeting over 30 corporations including Bank of America & Wells Fargo. We tracked \$546,223,784 moved off Wall Street & onto Main Street as part of the Move Our Money campaign. We helped launch a new network for and by homeowners, known as the Home Defender's League. NBL created & launched the "Home Is Where the Vote Is Campaign" to make the voice of the "underwater voter" and the housing crisis a major campaign issue through online & on the ground education and communication

MAIN STREET ALLIANCE NETWORK. AJS'S MSA program provided support to small business owners & small business groups in 15 states to elevate the voices of Main Street small business owners on issues that impact small businesses, their employees, & the communities they serve. National MSA staff provided training for new state affiliate staff, strategic planning support, research & materials development, organizing support, & national coordination for MSA affiliates in 11 states, and worked directly with small business owners in 4 more. MSA affiliates conducted outreach to thousands of small business owners, educated business owners about issues including health care, competitive tax policies, the influence of corporate money in politics, job quality and workplace benefits issues. MSA produced & released a series of reports, including "Making It on Main Street: An Agenda for America's Small Businesses and Local Economies"; and a series of reports with business partners based on a national survey of small businesses on jobs, access to credit, taxes, regulations, and money in politics.
