BYLAWS
of the
KENNETH HEINZ FAMILY FOUNDATION

ARTICLE I
BOARD OF DIRECTORS

Section 1: GENERAL POWERS. The affairs of the corporation shall be managed by its Board of Directors.

Section 2: NUMBER, TENURE AND QUALIFICATIONS. The number of Directors of the Board shall be not less than one (1) nor more than ~~five~~ (5). The number of Directors shall be fixed from time to time by the Board of Directors and the number so fixed shall comprise the entire Board of Directors. Directors shall be elected annually at the regular annual meeting of the Board of Directors. If the election of Directors shall not be held at such meeting, such election shall be held as soon thereafter as conveniently possible. Each Director shall hold office until his successor shall have been duly elected and shall have qualified or until his death or until he shall resign. Directors need not be residents of California.

Section 3: VACANCIES. In the case of any vacancy on the Board of Directors through death, resignation, disqualification or other cause, the remaining Directors by an affirmative vote of a majority thereof, may elect a successor to hold office until the next meeting for the election of Directors, and until the election and qualification of his successor.

Section 4: REMOVAL. A Director may be removed for cause by a vote of two-thirds (2/3) of all Directors then in office. Such action shall be taken at a regular meeting of the Board of Directors or at a special meeting called for such purpose, and the proposed removal shall be set forth in the notice of any such regular or special meeting, sent at least ten (10) days prior thereto.

Section 5: COMPENSATION. Directors shall not receive any stated salaries for their services, but by resolution of the Board of Directors a fixed sum and expenses of attendance, if any, may be allowed for each regular or special meeting of the Board, providing that nothing herein contained shall be construed to preclude any Director from serving the corporation in any other capacity and receiving reasonable compensation therefor.

ARTICLE II
MEETINGS

Section 1: ANNUAL MEETING. The annual meeting of the Directors of the corporation shall be held at its office in Walnut Creek, California, or at such other place within or without the State of California as may from time to time be selected by the Directors, on the date in each year designated by the Board of Directors, and at the time stated in the notice thereof, for the purpose of electing or appointing Directors or officers for the ensuing year and/or for the transaction of such other business as may properly be brought before the meeting.

Section 2: REGULAR MEETINGS. Regular meetings of the Board of Directors may be held at such time and at such places within or without the State of California as may from time to time be determined by resolution of the Board, which resolution may authorize the President to fix the specific date and place of each of such regular meetings, in which case notice of the time and place of such regular meetings shall be given in the manner hereinafter provided.
