WE DO THIS BY WORKING WITH CONSERVATION ENTITIES ACROSS THE YAKIMA BASIN TO IDENTIFY AND PRIORITIZE PROJECTS THAT INCLUDE THE REMOVAL OR REPLACEMENT OF HUMAN MADE BARRIERS, SCREENING IRRIGATION DIVERSIONS AND IRRIGATION DIVERSION IMPROVEMENTS AND REMOVAL OR IMPROVEMENT OF OTHER PASSAGE OBSTACLES.
