The Transitional Housing program services include professional case management, training, and counseling focused on helping residents in four key areas: 1) obtaining stable housing, 2) finding employment that pays a livable wage, 3) developing budgeting skills, and 4) improving life skills. We also provide child advocacy for the children in our program with the goal of bringing every child up to age-appropriate development in physical, social, academic, and emotional arenas. In 2012, the transitional housing program provided housing and services to 30 mothers and 55 children.

We also began a new program in September called Stable Families, which targets low income single parent families in imminent danger of losing their housing. Wrap-around support services include: 1) Emergency Assistance to resolve the housing crisis, 2) Case Management focused on housing stability, 3) training to develop budgeting skills, and 4) employment coaching. In 2012, Stable Families helped 10 parents and 19 children stay in their homes and avoid a homeless episode.
