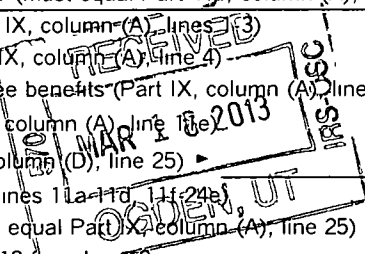

Food Program: The Food Program that the What If? Foundation has funded in the Ti Plas Kazo neighborhood of Port-au-Prince, Haiti, since 2000 continued to provide nutritious meals to children and some adults each weekday in 2012. On average, the cooking team prepared and served 1200 hot meals each weekday, and up to 1800 on the days following tropical storms and hurricanes that swept through Port-au-Prince in 2012.

Building Project: Forced to relocate the food and education programs after the January 2010 earthquake, the What If? Foundation launched a new building project that will provide a permanent home for the programs as well as a new neighborhood school. In 2012, funds were used to launch a fundraising effort for this campaign, to finish preliminary designs and engineering for the project, and to complete the construction of the property's perimeter security wall.
