Expense total includes \$404,563 in program materials (See Form 990 Part IX Line 24a) that consist of non-cash clothing and merchandise donations that were donated to the organization and then resold as thrift shop inventory (See Form 990 Part VIII Line 1a).

The homeless prevention grant is to prevent residents from becoming homeless or to transition residents from a homeless situation into housing. Funding supports activities such as utility shut-off and eviction prevention, first month's rent, laundry, showers and bedding (sleeping bags/tents), gas and stove oil (firewood). The Homeless Assistance Program grant is supplemented with a voucher program which enables the individual in need to purchase \$40 in thrift store clothing per household member.
