DURING 2012, THE ORGANIZATION HAD NO ACTIVITY, AND FORM 990-N WAS ORIGINALLY FILED. IT HAS SINCE COME TO LIGHT THAT THE ORGANIZATION'S STATUS CHANGED FROM PUBLIC CHARITY TO PRIVATE FOUNDATION IN 2011 WHEN NO CLINIC OPERATIONS AND NO WINDING UP ACTIVITIES WERE BEING CONDUCTED. THIS AMENDED RETURN IS BEING SUBMITTED TO COMPLY WITH THE REQUIREMENTS OF A PRIVATE FOUNDATION BY FILING FORM 990-PF.
