MEMBERSHIP ENGAGEMENT AND PUBLIC EDUCATION. The focus of this program's work is to position PSJ as a leader for facts & analysis on the need for reforming the criminal justice system & increase our member involvement in that reform. 3 issues of our newsletter, Justice Matters, were sent to over 2300 people with news, issue analysis & resource information. In 2012 we covered youth being processed for intake at adult prison, shifting opinions on public safety, successful Oregon reentry programs, & alternatives to incarceration that work. We sent out 6 electronic action alerts which resulted in 272 actions, and 32 electronic informational messages to our 2000 members. 288 volunteers performed 3223 hours of service with PSJ. We had 43,256 visitors to our website, & our facebook page was "liked" by 1100 people. PSJ was mentioned or quoted in 172 radio spots, 18 newspaper articles, 2 TV and other media posts, and had several guest columns published. Our statewide gathering drew 110 members; monthly action team meetings were attended by 267 members; & 441 people attended PSJ presentations.

CRIME SURVIVOR PROGRAM. PSJ is growing based on our report, "Moving Beyond Sides. The Power and Potential of a New Public Safety Policy Paradigm", released in Dec 2011. This concept paper describes & promotes a holistic approach to criminal justice policy that moves beyond the oppositional silos of victim advocacy & prison downsizing. This paper was disseminated & discussed with funders & practitioners in both fields, resulting in a collaboration of funders & policy advocates to organize 2 national convenings to further explore & promote such a paradigm shift. Our Program Dir & Executive Dir participated on the planning team, & PSJ played a lead role in coordinating the work. The first convening, held in Los Angeles in June of 2012, was attended by 25 crime victim advocates, criminal justice reform advocates, & funders. The second will be in Jan of 2013. In 2012 PSJ released a moving short film, Oregon Out of Balance. It's an examination of the ways Oregon can improve its approach to building safe communities. The film had 981 views & was distributed as part of a petition.

SAFETY & SENTENCING PROGRAM. This program develops approaches to public safety that more effectively build safe communities, are fiscally responsible, & reduce reliance on incarceration. 2012 marked the beginning of a more formalized partnership with the Oregon Student Association, one of the most dynamic organizations in the country led by young people. This partnership developed from the results of a 2011 survey of over 11,000 of their members which identified "Education Not Incarceration" as a key priority. PSJ played a significant role in a collaborative effort to develop the first Oregon racial equity legislative report card. This report, "Facing Race", examined 24 pieces of legislation introduced in the 2011 legislative session & graded each chamber of the legislature. We released the report on MLK Day of 2012 & hand delivered the report with our partners to the offices of all 90 legislators. To help bring attention to needed youth justice reforms, PSJ sponsored a 5K run/walk to commemorate National Youth Justice Awareness Month. About 60 people participated in the event.
