Project H E R The navigator program provided awareness, education and support for women in Benton, Linn and Lincoln counties of Oregon, from the time of breast cancer diagnosis through survivorship Support teams consisted of a nurse navigator, a clinical social worker, MammaCare specialists and many volunteers who were breast cancer survivors Project H E R served 302 newly diagnosed breast cancer patients last year The MammaCare program's nurses and clinicians taught 13 self-breast exam classes, reaching 216 women in the three Oregon counties A Puttin' on the Pink Education Day was held on October 10 for 200 individuals Attendees at the free day and evening events learned about healthy eating for cancer prevention Classes and exhibits also covered such topics as the best practice for self-breast exams, yoga and the power of acupuncture In addition, Project H E R nurses and clinicians participated in numerous outreach events to increase awareness of breast cancer prevention, including the Susan G Komen Race for the Cure in Eugene, Oregon, Pink Out athletic events held at the local university and high schools, and the Lunafest women's health film festival Another Project H E R program, Cook for Cancer, provided 81 meals for families of patients undergoing chemotherapy treatments of all types of cancer diagnoses, oncology and hematology

Emergency Assistance Grants 18 individuals received emergency assistance grants ranging from \$500 to \$1,200 each to help them through financial hardships These grants, paid directly to vendors such as banks and utility companies, supported the individuals' medical care, basic human needs such as rent or mortgage payments and utility bills, car loan payments, and other expenses that needed to be paid during individuals' medical illnesses, deaths in the family, and other unforeseen family circumstances

Health Education Scholarships, Grants, and Lecture Series Scholarships ranging from \$500 to \$1,000 each were awarded to 8 high school and university students who are pursuing careers as doctors, nurses, physician assistants, nurse practitioners, phlebotomists, and other medical professionals The Foundation co-sponsored a lecture on child abuse through its Eldon Younger Lecture Series, which was attended by more than 100 individuals, many of whom were local child care providers who received continuing education credit for attending The Foundation also provided a grant to the local hospital foundation for its Asbury Lectureship series on issues in obstetrcs and gynecology, which was attended by area physicians, nurses and other practitioners working in the area of women's health
