A prior period adjustment was made to the financial statements for the Western States Council during the 12/31/2012 Audit. A \$25,000 other asset (receivable) was removed from the Council's 2011 statement of financial position, and a corresponding \$25,000 expense was added to the statement of activities. Also, the pay for the executive administrator was increased by \$4,696 dollars due to the last paycheck for 2011 not being included in the 2011 audited financial statements. This created a \$29,696 decrease in the Net Assets at 12/31/2011. This is the cause for the discrepancy between the Net Assets ending balance per the 2011 Form 990 and the Net Assets beginning balance per the 2012 Form 990.
