Some key investigations in 2011/2012 included: 1) "How Big Telecom Used Smartphones to Create a New Digital Divide;" 2) "A Swamp of Predatory Lending Drowns Struggling Neighborhoods;" 3) "Voter Suppression Groups Plot a Million Person Army to Swarm Polls;" and 4) "Dispatch From Detention: This is What Humane Deportation Looks Like." ARC's largest investigative project which followed the attack on voting rights helped to shape the national conversation on the topic throughout the election season. In 2012, Colorlines.com's overall web traffic grew by nearly 50 percent, reaching more than 3.7 million unique visitors. During the all-important election season, Colorlines.com served more than 400,000 unique visitors a month.

ARC's Leadership Development program combines leadership development and education with strategic planning that focuses on advancing racial justice. ARC added two new trainers in 2012, and significantly expanded our reach by developing webinars. The new webinar series included the following: 1) "Racial Equity Impact Assessment" to introduce racial equity impact framework and tools used to prevent disparities and avoid unintended and adverse impacts; 2) "Challenging Racism Systematically" to help activists and others to become familiar with the different levels of racism and operate from a proactive racial justice framework; 3) "Changing the Conversation on Race" to help participants to avoid the pitfalls of talking about race, and learn to change the conversation; and 4) "Taking Real Steps Towards Racial Justice" to provide practical solutions for increasing racial equity. More than 1,400 individuals

registered for these ARC webinars in 2012. ARC also hosted the country's largest national racial justice conference in November 2012, where 1,400 individuals attended workshops, plenaries, and networking opportunities. The conference included over 50 workshops offered by over 100 presenters.

ARC's research explores the significance of race and ethnicity to our society's social and economic outcomes. Focusing largely on institutional and structural racism, as opposed to personal prejudice, ARC's research seeks to reveal the hidden or ignored inequities of public policies and practices both within and across interconnected sectors such as education, immigration, criminal justice, employment and health. In May 2012, ARC released a new report: "Millennials, Activism, and Race." This report, downloaded more than 1,200 times, detailed the results of nine focus groups conducted with young progressives to better understand what motivated them to engage in progressive organizations and movements. ARC continued forward with the 2011 "Shattered Families" report, publishing related articles, which further explored the plight of parents facing deportation. This resulted in 301 media hits that referenced or linked to Shattered Families report. In June 2012, ARC released "Better Together in Action: Organizations Working to Integrate Racial Justice and LGBT Issues," which profiled three organizations: The South Asian Network, FIERCE, and Southerners on New Ground. ARC's "Good Food, Good Jobs for All" was released in July 2012. This report revealed collaborative opportunities between groups working for good jobs and those focused on good food.

projects-BackStory Narratives, the Alliance of Californians for Community Empowerment (ACCE) and El Comité Del Pueblo-ARC added Laughter Against the Machine in 2012.
