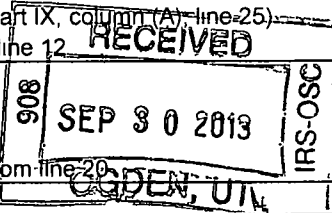

The Assistive Technology Network (AT Network) is dedicated to expanding the availability of tools, resources and technology that increases independence, improves personal productivity and enhances the quality of life of Californians with disabilities. We support 14 Device Lending Libraries, 30 Reuse Centers and 28 Independent Living Centers throughout the state. We provide funding, training, and technical assistance to a network of over 1500 organizations and individuals. We lead the California Assistive Technology Reuse Coalition made up of 14 organizations performing and promoting AT reuse initiatives. In 2012, our Device Lending Libraries made over 1300 device loans, and our Reuse Centers redistributed 5,935 used medical devices back into the community, including wheelchairs, walkers, hospital beds and adaptive computer equipment. We provided assistance for over 1000 information inquiries, and provided 26 trainings to nearly 500 participants. (Continued Schedule O)

Disability Organizing Network (Formerly called System Change Network) Disability Organizing Network (DO Network) Since 1998, CFILC has led our systems change efforts through a statewide Disability Organizing Network made up of stakeholders from the Independent Living Centers and the communities we serve. We support statewide reactive and regional proactive organizing campaigns that are driven by community members and focus on building accessible communities. We provide training, technical assistance and support to local communities as they develop strategies to increase access to housing, transportation, healthcare, education and the greater community. In 2012 we organized over 1500 people to network events and trainings. (Continued Schedule O)

Youth Organizing! Disabled & Proud (YO!) - is a project run by, for and about youth with disabilities, we provide volunteer opportunities within 15 Independent Living Centers for youth with disabilities aged 16-28. In 2012, our youth volunteers served over 2,500 hours. Their service hours included youth campaigns to end bullying, and to promote the teaching of Disability History and Bullying prevention. Together YO! volunteers reached over 7,500 students with 113 trainings across California.
