In 2012, ZYZZYVA successfully executed its primary project of publishing the tri-quarterly print journal. In keeping with our Mission over the past 28 years, our goal in 2012 was to continue publishing the journal and to continue our support for writers and artists. To that end, we published three exemplary issues of the journal in 2012, featuring new works by 36 authors, 28 poets, and 10 artists, in beautifully produced and carefully edited volumes which were distributed to bookstores and newsstands nationwide. We organized and participated in no less than 21 events to bring publicity and attention and a live audience to our authors. Nearly all of these events were free and open to the public. Work from our 2012 issues went on to garner important awards: a story was chosen for inclusion in Best American Short Stories, and an essay was chosen for inclusion in Best American Essays. We expanded our nonfiction work substantially, offering publication and financial support to brave and ground-breaking works by American and Mexican journalists. We continued to offer new talents their first works in print (featuring 4 previously unpublished authors in the journal over the course of the year), while also offering substantial support (through increased publicity in print, radio, and online media outlets, and through sustaining last years increased author payments) for all our authors, new and established.
