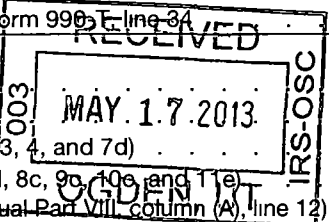

A center for monastic living and spiritual practice was maintained in Northern California where serious practitioners are allowed an opportunity to fully devote their life to God through selfless service and religious study.

Public preachers traveled throughout the Americas to present Krishna Consciousness to the general public through festivals, lectures and educational programs.

Preaching centers are under development and yoga centers visited to further the outreach objectives of the organization.
