The Foundation champions full and equal access to the justice system for all Californians by financially supporting nonprofit legal service organizations, courts, the State Bar of California, as well as local, specialty and minority bar associations. In 2012, the Foundation made \$342,900 in grants to law-related projects focused on increasing diversity in California's legal profession and helping rural communities access the legal system.

The Foundation seeks to build a diverse legal profession representative of and in service to California's myriad communities. The Foundation invests in the next generation of California attorneys by awarding scholarships to students from communities underrepresented in the legal profession, as well as to students and law school graduates intending to practice in the public interest. In 2012, the Foundation awarded more than \$142,500 in Diversity Scholarships to 19 students, over \$100,000 in Public Interest Scholarships to 21 students and \$35,000 in Rosenthal Bar Exam Scholarships to 15 students.

The Committee reviews comparability data regarding executive director salaries from a number of sources, including the Public Interest Clearinghouse, the Center for Non-Profit Management, and other national surveys. In its deliberations, the Committee also weighs the desire to reward excellence, encourage retention, and avoid replacement costs. The Committee presents its evaluation and salary recommendation to the full Board of Directors, which approves any adjustments to the Executive Director's compensation package.
