**HHS Mandate**  
Priests for Life issued a direct challenge to Obama Administration's attempt to force Catholics and all people of faith to take a direct role and cooperate in the gravely sinful act of killing innocent children in the womb. That challenge came in the form of a lawsuit: Priests for Life v Sebelius. Specifically, the lawsuit seeks to block enforcement of the HHS mandate that requires objectionable services to be included in health insurance. The Obama Administration's HHS mandate is a concerted attack on the Church in the United States, and an assault on religious freedom. The Priests for Life lawsuit was filed to protect that right, and in response to both the Holy Father's call to oppose those "attempts being made to limit that most cherished of American freedoms, the freedom of religion", and this statement from our U.S. bishops: "What is at stake is whether America will continue to have a free, creative and robust civil society - or whether the state alone will determine who gets to contribute to the common good, and how they get to do it."
