Working with local partners, we succeeded in stopping or suspending destructive dams, and protecting river ecosystems and the rights of local communities. After a 10-year struggle, communities managed to get a commitment from the State Governor to suspend the La Parota Dam planned for Mexico's Papagayo River. Lawsuits filed in Brazil led to suspensions in destructive dams planned for the tributaries of the Amazon River. Our campaign against the Xayaburi Dam planned for the mainstream Mekong River in Laos, while unsuccessful in stopping the project, was successful in ensuring that the Cambodian and Vietnamese governments continued to maintain their opposition to damming the Mekong mainstream, setting us up for future successes. In India, the government strengthened its policy on the environmental flows required to maintain river ecosystems downstream of dams, based on our input.

We continued to produce videos, reports, blogs and other materials in English and other languages to raise awareness of the impacts of damming rivers, and to showcase alternative means of meeting energy and water needs. We released a major new report documenting the hydrological risks of damming the Zambezi River as a result of global climate change. We also released important studies documenting alternative energy potentials for Guatemala, Brazil and Thailand. We participated in the Rio+20 events in Rio de Janeiro, Brazil, and brought media attention to the controversy surrounding the Belo Monte Dam project. We produced an updated version of our citizen's guide to Chinese overseas dam-builders "The New Great Walls" and circulated it widely. We held numerous civil society workshops in India and China to acquaint our partner groups with international standards and best practices regarding rivers and dams.
