 THE JUNIOR GIANTS PROGRAM WAS ESTABLISHED IN 1994 AS THE FUND'S FLAGSHIP PROGRAM AND CURRENTLY SERVES OVER 20,000 BOYS AND GIRLS, AGES 5 TO 18 IN MORE THAN 85 COMMUNITIES THAT SPAN ACROSS NORTHERN CALIFORNIA, OREGON, AND NEVADA. THE PROGRAM RELIES ON OVER 2,200 VOLUNTEERS AND STAFF MEMBERS TO RUN THE NON-COMPETITIVE LEAGUES. THE FUND PROVIDES ALL OF THE UNIFORMS, EQUIPMENT, AND TRAINING NECESSARY TO RUN A LEAGUE AS WELL AS TICKETS TO SELECT SAN FRANCISCO GIANTS GAMES FOR THE YOUTH TO EXPERIENCE MAJOR LEAGUE BASEBALL. THE PROGRAM FOCUSES ON THE FOUR BASES OF CHARACTER DEVELOPMENT - CONFIDENCE, INTEGRITY, LEADERSHIP AND TEAMWORK.
