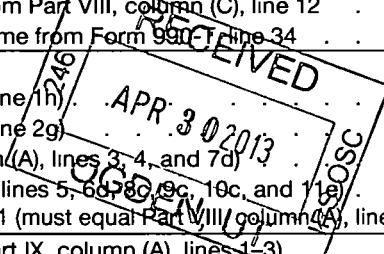

**Teacher Services: CRS provided over 1,000 Kindergarten through 6th grade educators with comprehensive information, reference, personalized support, web-based resources, training, and other support related to science teaching and learning. CRS served classroom teachers in 95+ schools in the East Bay, including every elementary school in Oakland, Berkeley, and Emeryville. CRS provided over 200 custom research reports and responded to over 1,100 individual teacher requests. The teachers served in this program educate over 25,000 students, mainly in high-need, under-resourced public elementary schools.**

**Bay Area Scientists in Schools (BASIS): The CRS scientist volunteer program recruited, trained, and placed over 450 scientists into Kindergarten through 6th grade classrooms to present engaging, standards-based, hands-on science lessons. Scientists also serve as diverse, enthusiastic role models who inspire young students to learn about academic and career options in science. Scientist volunteer teams presented 450 lessons in East Bay classrooms in 2012, engaging over 10,000 students in science learning activities. The lesson plans and related material lists, science content background, and teaching tips are made available to classroom teachers hosting scientist team visits; the materials are also archived and accessible on the CRS website.**
