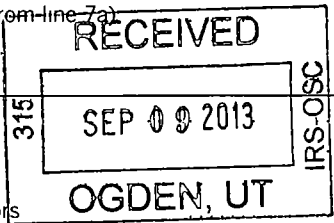

Part I, Line 20 During 2010, the Organization experienced several crises. Our funding was severely reduced, our Executive Director took an extended maternity leave due to some health challenges, and we had a part-time interim director filling in for several months. Around that time we lost several of our staff members and did not feel we had the funding or hiring support to replace them. Shortly thereafter, our Executive Director resigned. After much deliberation, the Board of Directors decided that it was necessary to dissolve the Organization. After October, 2010, we had no staff at all. Throughout its history, GirlSource has maintained a full-time staff that managed the day-to-day finances and operations of the Organization. Board members have functioned in leadership and oversight roles only. The volunteers on the Board did not have the capacity to assume all staff roles, particularly given the rapid pace at which staff was depleted. Because we had insufficient funds to keep our office space, the Board had to quickly shut down the entire physical operation and move all its assets into storage. As a result, we were unable to locate the computer containing our accounting records, necessitating reconstruction of financial information from paper records. In the process, an error was made recording payments of debt, the balance of which was subsequently forgiven, to a savings account, overstating cash balances at 12/31/11.
