During 2012, the ATP successfully governed the men's professional tennis circuits through its operation of professional tennis events and its promotion of players, tournaments and the sport as a whole. Record revenues in 2012 meant that the ATP was able to return more value to its tournament and player members than ever before through sponsorship and TV revenue for tournaments, and prize money and pension benefits for players.

The ATP successfully marketed and promoted men's professional tennis to a worldwide audience in 2012, with close to 4.4 million spectators attending ATP World Tour events, and record audiences on TV and online. The ATP successfully promoted its members through its global marketing & advertising campaign, PR initiatives, as well as through its weekly magazine show, ATP World Tour Uncovered, which was viewed in more than 150 countries worldwide. A record 800 million dedicated television viewers across 185 countries tuned into ATP World Tour tennis. Total broadcast hours of ATP events were up more than 30% globally, reaching 100,000 hours for the first time, whilst an average of 4 million fans visited ATPWorldTour.com each month.

The ATP successfully governed the men's professional tennis circuits - the ATP World Tour, the ATP Challenger Tour, and the ATP Champions Tour. The 2012 ATP World Tour season comprised 62 events and saw record prize money of \$83 million, whilst the ATP Challenger Tour comprised more than 145 events. A bonus pool totaling \$8 million was paid out to eligible players competing on the ATP World Tour circuit. In addition, the season-ending Barclays ATP World Tour Finals welcomed 263,000 fans to the tournament, meaning the event has welcomed more than 1 million fans since it moved to London in 2009.
