

As reported with the Form 990-PF for the tax year ending December 31, 2009, in September 2010, the Foundation’s Board of Directors realized that the 1977 Amendment to Article Eighth of the Articles of Incorporation, requires the Foundation to distribute all of its assets within a year of funding. Upon advice of legal counsel that IRC §4942 does not require such distribution, Article Eighth was amended to eliminate that requirement.

In November 2010, the Board amended its Articles of Incorporation, repealing the 12-month asset distribution provision of the prior Article Eighth.

Attached hereto are copies of the following documents:

1. Minutes of Special Meeting of Board of Directors of W. Sherman Winseman Foundation; and
2. Certificate of Second Amendment of Articles of Incorporation of W. Sherman Winseman Foundation, dated November 12, 2010 as filed with the California Secretary of State on January 13, 2011. The as then unfiled copy of this document was originally submitted with the 2009 tax return, and the filed copy has been submitted with each year’s tax return since then.

Dana Winseman, on advice of the Foundation's legal counsel, stated that such amendment is not now, and was not in 1977, required under Internal Revenue Code §4942, and that such a limitation will unnecessarily burden the Foundation.

Upon motion made, seconded, and unanimously carried, the

following resolution was adopted:


RESOLVED, that the Articles of Incorporation be amended by repealing Article Eighth and substituting the following in its place:




