Provides job skills and supplemental income to 33 poor rural households. Sold 141,834 RBM in cards during 2012.

In 2012, the Yuci Evergreen staff provided various services, e.g., surveyed people for various studies, conducted home visits, and administered physicals, to a total of over 7,052 individuals. In addition, the staff provided approximately 294 person-hours of health education for community members, helped manage chronic diseases for 1,508 people and conducted medical training for over 250 people (over 1403 person training hours).

4c (Code:) (Expenses \$ 18,004. including grants of \$) (Revenue \$ 1,202.)

Yangqu Community Center:

The number of library card holders is 20,000. The English Classes served a total of 107 students. The calligraphy, arts and crafts, and early childhood education classes with a focus on encouraging the student, and offering interactive western teaching methods served 120 students. The bookmobile impacted 2,000 students and teachers monthly throughout Yangqu and Taiyuan (2 village schools). There was also a summer English camp which served 72 students.
