AWBW PROVIDED ART AS A HEALING TOOL TO SURVIVORS THROUGHOUT LOS ANGELES COUNTY AND NATIONWIDE AT OVER 219 DOMESTIC VIOLENCE AGENCIES IN 30 STATES. IT HELPED BUILD THE CAPACITY OF THESE SHELTERS BY TRAINING SHELTER STAFF TO DEVELOP AND LEAD WEEKLY ART WORKSHOPS THAT EXPLORE SPECIFIC THEMES IN HEALING FROM ABUSE, SUCH AS HANDLING ANGER, REBUILDING SELF-CONFIDENCE, AND LEARNING POSITIVE COPING SKILLS.
